2. Fill out an application for a Temporary Food Facility permit, submit it to the Amador County Environmental Health Department, and pay a \$60 fee* no later than February 15, 2020.

** Non-profit and Veterans organizations are exempt from paying this fee, but still must submit an application for the permit.*
